BEFORE ME THE UNDERSIGNED AUTHORITY, IN AND FOR SAID COUNTY AND STATE, ON THIS 11/08/99 DAY OF NOVEMBER, 1999, PERSONALLY APPEARED MARVIN COOPER WHO AFTER BEING BY ME DULY SWORN DEPOSES AND SAYS:

MY NAME IS MARVIN COOPER. I HAVE BEEN EMPLOYED BY THE ORANGE COUNTY SHERIFF'S DEPARTMENT FOR THE PAST 6 YEARS. MY PRESENT RANK IS SERGEANT. I HAVE 15 YEARS OF LAW ENFORCEMENT EXPERIENCE.

I HAVE GOOD REASON TO BELIEVE AND DO BELIEVE THAT JOHN J. HARGROVE, WM, DOB 09/05/73 IS GUILTY OF THE OFFENSE OF ASSAULT CLASS A FAMILY VIOLENCE BASED ON THE FOLLOWING FACTS:

I HAVE READ AN OFFENSE REPORT MADE BY SGT. COOPER, WHO IS A CERTIFIED TEXAS PEACE OFFICER AND IS CURRENTLY EMPLOYED BY THE ORANGE COUNTY SHERIFF'S DEPARTMENT. THE REPORT STATES;

ON 09/30/99, LENORA CARDNER CAME TO THE ORANGE COUNTY SHERIFF OFFICE TO FILE A ASSAULT CLASS "A" FAMILY VIOLENCE REPORT. MRS CARDNER SAID, SHE WAS TALKING WITH HER COUSIN, TRACY GREEN, AND TRACY TOLD HER THAT HER MOTHER WAS GOING TO CALL HER EX-HUSBAND AND HAVE HIM PICK-UP HER CHILDREN. MRS. CARDNER CALLED HER MOTHER AND SHE STARTED CURSING HER OUT AND SAID SHE WAS A MENTAL CASE. MRS CARDNER STATED THAT SHE WENT TO HER MOTHER'S HOUSE WITH A TAPE RECORDER, AND TOLD HER MOTHER THAT SHE WAS RECORDING HER CONVERSATION WITH HER. MRS CARDNER SAID, SHE WAS ON THE PORCH, AND SHE DID NOT ENTER HER MOTHER'S HOUSE, NOR DID SHE MAKE ANY THREATS TO HER MOTHER OR HER BROTHER. MRS. CARDNER SAID THE NEXT THING SHE REMEMBERS WAS HER BROTHER, JOHN HARGROVE CAME RUNNING OUT THE HOUSE, AND ATTACKED HER. MRS. CARDNER STATED THAT HER BROTHER CHOKED HER AND SLAMMED ON THE CONCRETE DRIVEWAY. MRS. CARDNER SAID, SHE HIT THE DRIVEWAY AND SHE LANDED ON HER HEAD. MRS. CARDNER SAID, SHE RECEIVED TWO LUMPS TO HER HEAD, WHEN HER HEAD HIT THE DRIVEWAY. MRS. CARDNER ALSO SAID, SHE WAS KNOCKED A LITTLE DIZZY FOR A MINUTE AND SHE JUST LAID ON THE GROUND FOR A WHILE. MRS. CARDNER STATED, SHE TRIED TO PUSH OR HIT HER BROTHER OFF OF HER. MRS. CARDNER SAID, SHE WAS ABLE TO GET AWAY FROM HER BROTHER AND SHE DROVE TO THE ORANGE COUNTY SHERIFF OFFICE TO FILE A REPORT.

PHOTO'S WERE TAKEN OF MRS. CARDNER INJURIES.
